

## 94.7 WCSX What Makes Your School Cool - Official Contest Rules

### Contest Dates

*April 4<sup>th</sup>, 2016 through April 22<sup>nd</sup>, 2016 at 11:59pm (ET): submission of entries/nomination of schools will take place ("Entry Period").*

*April 26<sup>th</sup>, 2016 through May 12<sup>th</sup>, 2016 at 11:59pm (ET): online voting will take place ("Voting Period").*

*On or about May 13, 2016: winning entry will be selected*

### How to Enter or Participate for a Chance to Win

Enter online during the Entry Period at [www.wcsx.com](http://www.wcsx.com) by completing and submitting the online entry form and telling us about an elementary school you would like to nominate to win an ice cream party. Entry form must be filled out completely, including all required contact and personal information, to be entered into the contest. Must be a WCSX Workforce Member to participate; become a Workforce member at [www.wcsx.com](http://www.wcsx.com). There is no charge to join. All contest entries will become the property of WCSX (Station) and will not be acknowledged or returned. **By submitting an entry, all entrants grant Station permission to read their entry on-air and to post their entry on [www.wcsx.com](http://www.wcsx.com) for voting and promotional purposes.** Limit one entry per person and per email address per day during the Entry Period.

### Winner Selection

During the Voting Period, listeners can visit the "What Makes Your School Cool" contest page at [www.wcsx.com](http://www.wcsx.com) to vote for their favorite entry. Limit one vote per person per day. WCSX will select the winner in its sole discretion, taking into account the voting results. *One winning entry will be selected on May 13<sup>th</sup>, 2016.* Winner selection is subject to confirmation of eligibility. Initially-selected winning school must confirm acceptance of prize within 30 days of initial notification. Failure to do so may result in disqualification and selection of a new winner. Total of one (1) grand prize winner will be selected. Winning entrant will be notified by phone, and may be asked to help coordinate notification of the winning school.

NOTE: the winning entrant (the person who actually entered the contest and nominated the winning school) will NOT receive a prize.

### Prize

One (1) Grand Prize will be awarded, consisting of:

An Ice Cream Party at the winning school which includes: one (1) ice cream novelty item for up to 1,000 kids. Approximate Retail Value: Up to \$2000.00. Ice Cream Party must be scheduled in 2016 on a date that is mutually agreeable for the school, WCSX, and the prize provider. The nominated school must be an elementary school (offering one or more of Kindergarten and Grades 1-6) located in one of the following Michigan counties: Oakland, Wayne, Macomb, Lapper, Livingston, St. Clair. Employees (including their immediate families and members of the same household) of Greater Media Detroit, its affiliates, and promotion sponsors/prize providers are not eligible to participate. The term "immediate family" includes spouses, siblings, parents and legal guardians, children and legal wards, grandparents, and grandchildren, including "in-laws." Void where prohibited.
